

Activity Report of the Foreign Policy Association (APE)
Reporting Period: January – December 2025

I. APE's Research Activity

During the reporting period, APE carried out the following activities in line with its objectives:

- Drafted and published six monthly bulletins featuring summaries and debates on foreign policy (the FES/APE Monthly Bulletin); these were published and electronically distributed to over 1,000 subscribers from various target groups (Annex 1);
- Prepared and edited four Youth Information Bulletins (the PIN/APE Monthly Bulletin) (Annex 1);
- Produced and published 21 analyses and studies on national security; the importance of minimizing information security risks in the Republic of Moldova in the context of hybrid threats; security in the Black Sea region; electoral processes in the Republic of Moldova and Romania (Annex 1);
- Participated in more than 52 events, including conferences, roundtables, consultations, webinars, meetings, and national and international debates (Annex 1);
- Gave interviews for local television stations by members of the Association (Annex 1);
- Maintained and regularly updated the APE website (<http://www.ape.md/en/>), which includes studies, publications, commentaries, and press releases regarding events organized by APE;
- Updated the APE Facebook page, where APE experts share brief information about analytical materials and studies produced, interviews given, projects carried out, press releases, as well as media materials from organized events, also serving to maintain communication with the Association's target groups;
- Cooperation with the team of the Center for Organizational Training and Consultancy (CICO), with support from the U.S. Embassy in the Republic of Moldova, to review and develop internal documents and improve the financial policies and procedures of the Public Association "Foreign Policy Association" (APE) for the period 2025–2026.

II. Project Implementation Activity

1. Implementation and completion of the project: "Strengthening Youth Civic Engagement for Moldova's Democratic Resilience and European Future," People in Need, Moldova – ASSIST: Improving Access to Quality Public Services and Social Cohesion, funded by the EU.

The project will focus on young people aged 18 and above, particularly those from regions with a high concentration of Russian-speaking populations. This includes ethnic minorities and representatives of youth organizations and movements. The main objectives are to increase civic activism among young people, to counter disinformation and propaganda, to promote social cohesion and dialogue, and to improve media literacy and resilience to disinformation. To achieve these objectives, the project will organize six media education courses in local communities (Bălți, Edineț, Comrat, Taraclia, Dubăsari, Chișinău) to educate at least 120 young people on media literacy and resistance to disinformation. In addition, six workshops will be held in Chișinău with youth representatives from diverse backgrounds (ethnic minorities, Russian speakers, youth organizations) to foster dialogue and understanding. Awareness campaigns will also be developed, including three video spots on civic engagement and Moldova's democratic resilience.

2. Implementation and completion of the project: “Defining and Countering Anti-Western Narratives in the Republic of Moldova: An In-Depth Audience Analysis”, carried out in partnership with ASPEN Romania and the German Marshall Fund.

The anti-EU/anti-Western disinformation campaign in the Republic of Moldova has two main objectives. On the one hand, it seeks to reduce public support for the country's accession to the EU. On the other hand, it aims to delegitimize political leaders who advocate for such a choice and, more broadly, to undermine trust in national institutions themselves. The information space of the Republic of Moldova (info-media) is alarmingly exposed to both external and internal anti-EU disinformation activities. These activities have intensified, targeting citizens political participation by eroding their confidence in democracy and in democratic institutions and processes such as referendums. Moreover, Kremlin-linked actors, by attacking EU institutions, seek to delegitimize their effectiveness and the future enlargement processes in Eastern Partnership countries.

3. Regional projects carried out in partnership with APE

- Continuation of the project **“Eastern Partnership Plus,”** implemented in cooperation with *Zentrum Liberale Moderne*;
- Implementation of the project **“Addressing the Common Challenges to Democracy in the Western Balkans and Eastern Partnership,”** implemented with the *Forum 2000 Foundation* (Czech Republic) and supported by the *Visegrad Fund*.

III. APE's Planned Activities for 2026:

- Drafting and publishing policy briefs on the challenges and prospects of the Republic of Moldova's EU accession; confidence-building processes in the Transnistrian settlement; information resilience and reintegration efforts; state resilience development; and cooperation relations, including Moldova–U.S., Moldova–EU, Moldova–Romania, Moldova–Ukraine, Moldova–Georgia, Moldova–Poland, and Moldova–Russia political dialogue, etc.;
- Submitting funding applications for new projects, preparing the relevant internal documents, including conducting an organizational audit;
- Organizing approximately five public discussions with academia and university communities (students and professors) across the Republic of Moldova;
- Co-organizing, together with FES of the annual debate forum on the European integration of the Republic of Moldova, to be held in Chișinău in 2026;
- Expanding cooperation with partner organizations from Ukraine, Romania, Georgia, Poland, and the Czech Republic for developing and implementing new projects;
- Developing internal documents, improving APE's financial policies and procedures, and implementing APE's Strategic Development Plan for 2026–2027.
